During the last year, the Brazilian Chapter continued promoting its activities using social media and a mailing list. The preceding numbers are valid as of 5 July 2023. In 2022, the total number of members was 43 in all (31 regular members; 8 student members; 4 retired members; 1 institutional member; with 34 members from the US; 6 from Canada; 3 from Europe [France, Denmark, and the Netherlands]). In 2021, the total number of members was 67 in all (46 regular members; 12 student members; 4 retired members; 1 institutional members; with 55 members from the United States; 11 members from Canada; 1 member from Europe (France]). As we can see, the number of members has gone from a peak of 67 members in 2021 to a trough of 43 in 2022 and now has now recouped partially with 51 in 2020. The peak-trough-peak fluctuation is due to the timing of the NASKO Symposia. Persons who are not members of ISKO register at a higher conference rate than members but part of this registration fee is put towards a complimentary membership to ISKO for the year of the NASKO conference. Some of these conference-based members renew their memberships

but many do not. As a consequence, ISKO-CUS tends to have higher membership numbers in years of NASKO symposia (typically odd-numbered years) than in even-numbered years. What is new and unexplained is the dramatic decrease in membership by approximately 1/3 from 2021 to 2022. The 2021 NASKO Symposium was very successful and attracted a number of new members but many did not renew. Moreover, some longtime members retired in 2022 and chose not to retain a membership in the organization. This may account for the drop in "individual"-level memberships but it does not explain the magnitude of the drop. It is notable that the vast majority of ISKO-CUS members come from the United States, while a relatively small number comes from Canada. One would like to see a greater number of members from the latter country, especially now that it is the legal home of ISKO. However, membership is often tied to strong representation of KO in i-School departments and, currently, there is only i-School in Canada that has a faculty member active in ISKO.

Comment on finances:

The finances of ISKO-CUS have remained stable over the past year, with predictable expenditures – namely, remittance of fees to ISKO's Central Offices, bank wiring fee, website fee, and incidental expenses relating to NASKO). Over the past three years, NASKO-related expenses have been minimal because the conference has been held online: if, in the future, in-person meetings resume, it is expected that annual expenses will increase by \$ 1,000-\$1,500 USD per year.
